**ADVISORY**

Whereas, in exercise of the powers conferred by sub-section (1) of Section 8 of the Cable Television Networks (Regulation) Act, 1995 (7 of 1995) (hereinafter referred to as ("the Cable Act"), the Ministry vide its Notifications No. S.O.2693 (E) dated 05.09.2013 and subsequent notification No. S.O. 1388 (E) dated 25.05.2015 and S.O. dated 1699 (E) dated 07.05.2019 has specified a list of channels that are to be mandatorily carried by the MSOs and Cable Operators on their cable TV Networks.

Whereas, S.O. 4136(E)- Dated 15.11.2019, in exercise of the powers conferred by subsection (1) of Section 8 of the Cable Television Networks (Regulation) Act. 1995 (7 of 1995), the Central Government hereby makes the following further amendments in the notification of the Government of India in the Ministry of Information and Broadcasting, No. S.O. 2693 (E) dated 05.09.2013 (hereinafter referred to as the "principal notification") namely: -

In the principal notification, -

- (i) In Table-I, after serial number 26 and the entries relating thereto, the following serial number and entries shall be inserted, namely:-

"27	DD Yadagiri	General Entertainment (Regional)";
-----	-------------	------------------------------------

Whereas, cable TV digitization has been completed, it is obligatory for the cable operators to carry 27 channels of Doordarshan including DD Yadagiri Channels, besides, Lok Sabha and Rajya Sabha channels.

Whereas, non-carriage of mandatory channels is liable to attract Section 11, Section 12 and Section 18 of the Cable Act.

All MSOs and Cable operators are accordingly advised to carry the mandatory channels in the manner as notified by the Ministry.

Any violation of Section 8 of the Cable Act shall invite such action as provided in the Cable TV Act and the Rules framed thereunder as well as the terms and conditions stipulated in the MSO permission, as the case may be.
