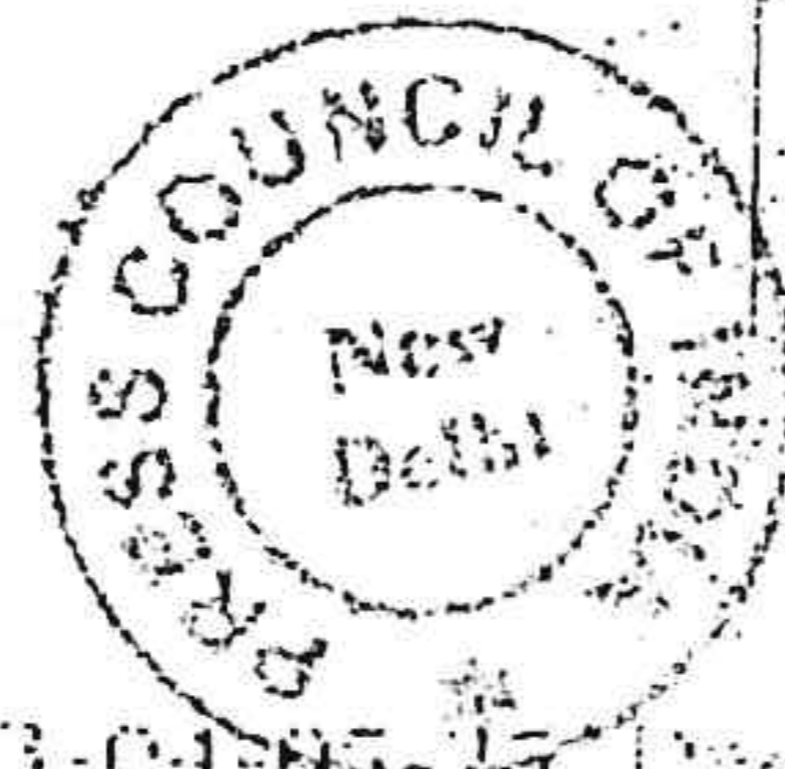

2. The pay and allowances of the officer selected will be regulated in accordance with the Press Council of India (Terms & Conditions of Service of Employees) Regulations, 2002 read with relevant provision's of Central Government of India on the subject matter.
3. The post is to be filled up by deputation on Foreign Service terms and conditions for a period of 03 years in the first instance, extendable/curtailed as per extant rule/order of Govt. The employees of the Council are not eligible for allotment of general pool accommodation. They are entitled to payment of HRA at prescribed rates applicable to the Central Government employees posted at Delhi/New Delhi.
4.
